 - 4) That the school timings, vacations and mid terms holidays shall be prescribed by the government from time to time.
 - 5) That the qualified staff with in the age limits prescribed by the Government for Government employees shall be appointed as per the staff pattern.
 - 6) That the results of the institution shall be satisfactory of every year.
 - 7) That the records / accounts, annual administrative report along with the audited accounts should be submitted to the District Educational Officer. every year.
 - 8) That the list of Governing Body shall be furnished to the D.E.O., every year.
 - (9) That the pay structure / fee structure fixed by the Governing body shall be submitted to the District Educational officer every year
 - (10) That all the conditions prescribed in the G.Os and other orders which are not specified in this orders shall be complied with.
 - (11) That the school shall not be closed with out giving notice both to the parents / Dist.Ednl,Officer, and the competent authority at least 6 months before.
 - (12) That the school shall be closed (or) permitted to be closed only from the date on which summer vacation is declared.
 - (13) That the school management shall obtain No Objection Certificate from Fire Service Department from time to time by renewal.
 - (14) That the society shall submit proposals for renewal of Prov.Recog. sufficiently in advance i.e., at least 6 months prior to the date of expiry of recognition.

Provisional Recognition to classes VI to X(EM) up to 2019-2020 in respect of Nirmala

High School, Atmakuru, Mangalagiri Mandal, Guntur District in the orders 1st read above. The Deputy Educational Officer, Tenali, Guntur District has recommended for Grant of Extension of temporary Recognition to Classes VI to X (EM) for a period of 10(Ten) years from 2020-2021 to 2029-2030 vide letter 3rd read above. The District Educational Officer, Guntur District has verified the application for Grant of Extension of temporary recognition with reference to the Inspection Report of the Inspecting Officer and also with the reference to the conditions laid down in the permission orders and G., O.Ms.No:1 Edn., (PS-f) Rules Department Dt:1-1-1994 and submitted a report in his letter 4th read above.

After Careful examination of the references read above and the conditions prescribed in G.O.Ms.No:1 Edn, Date:1-1-1994 ,G.O.Ms.No,41 Edn, Date: 11-05-2006, G.O.Ms.No. 74 Education Dt: 11-09-2006 and as per the instructions issued by the Commissioner and Director of School Education, Andhra Pradesh, Hyderabad in the reference 10th cited, the Regional Joint Director of School Education, Guntur is here by accords for grant of Extension of temporary Recognition to classes VI to X (EM) for a period of 10(Ten) years from the academic year 2020-2021 to 2029-2030 in respect of **Nirmala High School, Atmakuru, Mangalagiri Mandal, Guntur District** without aid now or in future. However by the end of April every year, the Educational Agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time and the management is requested to comply with the following without fail.

1. That the society shall abided the instructions, rules and regulations made by Government or authorized officer from time to time.
2. That the Educational Institution shall serve the needs of the locality more Particularly.
3. That the instructions shall adopt the curriculum and syllabus prescribed from time to time
4. The school timings, vacation and mid-term holidays shall be as prescribed by the Government from time to time.
5. That the qualified staff with in the age limits prescribed by Govt., for Govt., Employees shall be appointed as per the Staff pattern.
6. That the results of the Institutions shall be satisfactory every year.
7. That the records /accounts shall be furnished to the D.E.O every year.
8. That the list of Governing body shall be furnished to the D.E.O. every year.
9. That the pay structure/fee structure fixed by the governing body shall be got approved by the D. E.O. every year.
10. That all the conditions prescribed in G.Os and other orders which are not specified in this order shall be complied with.
11. That the school shall not be closed without giving notice both to the parents/DEO and competent authority at least 6 months before.
12. That the school shall be closed or permitted to closed only from the date on which summer vacation is declared.

13. That the society shall submit proposal for renewal of Extension of Temporary Recognition sufficiently in advance i.e., at least 6 months prior to the date of Expiry of the renewal.

14. The Recognition now given is purely on a temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under the A.P. Education Act, 1982 and if later found that the School has not fulfilled any prerequisites as stipulated, the Recognition now being given is liable to be withdrawn at once.

15. The Management is requested to follow the instructions of the Fire Department and renew the Fire Certificate from time to time without fail and submit the same to this office through the Deputy Educational Officer, Tenali And District Educational Officer, Guntur District.

16. The Management is requested to renew the Vehicle Fitness Certificate every year from the concerned authorities without fail and submit the same to the concerned Deputy Educational Officer.

Further, the managing committee of the school is requested to fulfill all requirements to cope up with the needs of the institution at the latest before submission of application for extension of Temporary Recognition for the year 2030-2031.
